Under these specific circumstances, the deposit will be refunded to the Purchaser. Cancellation of event or performance by Purchaser(s) for any reason does not warrant return of any deposit paid (*later than 30 days before event*).

13. Purchaser(s) warrant that he/she/they is/are of legal age and has the right to enter into this contract.

14. Either party may cancel this agreement without obligation, if notice is received 30 days before event.
